The Chairman and Secretary, Vivekanandha Dental College for Women, Elayampalayam, Thiruchengodu, Namakkal District has applied for increase of seats from 50 to 100 in Vivekanandha Dental College for Women Elayampalayam, Thiruchengodu, Namakkal District. On careful consideration of the proposal, the Government of Tamil Nadu has decided to issue an Essentiality Certificate for the increase of seats from 50 to 100 in Vivekanandha Dental College for Women Elayampalayam, Thiruchengodu, Namakkal District from the year 2013-14 subject to the condition that the approval of Dental Council of India / Government of India should be obtained before the students are admitted for the increased seats in the Dental College.

It is certified that:

- a) The applicant owns and manages 100-bedded Hospital.
- b) The applicant owns and manages a Dental clinic with 209 Dental Chairs.
- c) It is desirable for increase of seats from 50 to 100 in the Dental College in the Public interest
- d) Minimum 30 OPD Dental patients per day are available to begin with - approximately 100 OPD per day.
- e) The credibility and financial status of the applicant has been verified.

It is further certified that in case the applicant fails to create infrastructure for the Dental College as per Dental Council of India norms and fresh admissions are stopped by the Dental Council of India, the State Government shall take over the responsibility of the students already admitted in the College with permission of the Central Government.
