3. The Director of Medical Education has nominated inspection teams for conducting inspections and sent her report and recommendation about the desirability and feasibility for starting MDS courses.

The Government after verifying the desirability and feasibility, convey permission / Essentiality Certificate to start the following MDS courses in the Vivekananda Dental College for Women, Elayampalayam, Tiruchengode from the academic year 2015 – 2016 with annual intake noted against each specialty, subject to condition that the approval of Dental Council of India and Government of India should be obtained before the students are admitted to the respective courses:
